Indian Summer Oncology Camp: the longest running program of Kids Cancer Alliance, Inc. is a week long, overnight camp. Our week long summer camp is open to children aged 6-18 who are either currently undergoing treatment for cancer or if they are a survivor of a childhood cancer. At Indian Summer Camp, they aren't cancer patients; they're just kids being kids. We served 119 children with cancer at Indian Summer Oncology Camp in 2019.

4b (Code: ) (Expenses \$ 226,079 including grants of \$ ) (Revenue \$ )

Indian Summer Sibling Camp: The Sibling Camp program is a camp aimed to address the unique needs of children who have a brother or sister with cancer. Often times, when a child is diagnosed with cancer, their siblings experience a wide range of emotions and may feel left out, scared, and alone. Our Sibling Camp offers these children a special place where they can bond with others with similar circumstances, gain recognition, and learn that they are special too, all while having the time of their lives. We served 122 siblings at our Sibling Camp in 2019.

Survivor Scholarships: The KCA Scholarship program was established to support young adult cancer survivors and their siblings by assisting them in pursuit of their academic and professional goals. The scholarships are designed to ease the financial burden of obtaining an education from an accredited university, community college, vocational or technical school. Applications are open to individuals who meet the criteria, demonstrate financial need, and show academic and personal potential.
